There are also significant tax savings that can be realized for the estate. Donations made in both the year of death and under the individual's will can be claimed in the year of death and, if necessary, carried back to the preceding year. The 100% net income limitation applies to both the year of death and the preceding year. The donation credit also applies to gifts of RRSPs, RRIFs and life insurance proceeds.
